## MECHANISM FOR FINANCIAL RISK MANAGEMENT OF INDUSTRIAL ENTERPRISES

The industrial and commercial activity of industrial enterprises operating in various fields and types of activity are accompanied by financial risks. Moreover, any decision made among other alternatives, always accompanied by the threat of financial losses. In different fields of activity of industrial enterprises, there are corresponding factors of influence that cause risks of financial losses, which lead to a decrease in the level of financial security of an enterprise. In view of this, of the development of an effective mechanism for financial risk management of industrial enterprises is an urgent task, the solution of which will create the proper conditions for their successful functioning and sustainable development.

The conducted research has allowed the authors to make the following conclusion. Based on the implementation of stated stages of a comprehensive phased mechanism for financial risk management of industrial enterprises and focusing on the chosen strategy to counter the factors that cause financial risks, it is possible to achieve the expected result, namely, improvement of financial security and sustainable development of industrial enterprises by minimizing the negative impact of financial risks of external and internal environment.
