

FINANCIAL AND ECONOMIC SECURITY OF AGRICULTURAL ENTERPRISES BASIS OF ECONOMIC SECURITY OF THE STATE

Events of recent years have been characterized by considerable variable, contradictory and unexpected processes in the global geo-economic system, which require the reassessment and instruments development of the adequate economic security policy aimed both at strengthening the current state of affairs and ensuring sustainable long-term growth and development of agricultural enterprises and as a consequence of the national economy.

One of the important tasks in this situation is to find ways to counteract the crisis processes, as well as to put in place adequate tools to promote positive economic dynamics. In the context of rapid changes in the internal and external environment, rapid adaptation of agricultural enterprises to aggressive economic conditions is needed in order to ensure financial and economic security.

Although a large amount of scientific and practical research is devoted to financial and economic security of the enterprise, many matters remain debatable and require further scientific research.

Analysis of the approaches of scientists and practitioners shows that: there is a lack of unity in understanding the content and structure of the financial and economic security system of the enterprise, fuzzy principles of formation of the system of financial and economic security of the enterprise, discrepancies in the definition of the object and subject of the financial and economic security system of the enterprise, insufficient study of the relationship between the enterprise and state security.

Formation of a new structure of the macroeconomic and aggressive environment also requires a new quality of national institutes of economic security of enterprises, which, in turn, provokes new additional risks.

The main purpose of the paper is to analyze the relationship between financial and economic security of agricultural enterprises and economic security of the state.

Features of formation and management of the system of financial and economic security of agricultural enterprises are considered in the article. Main risks and factors that cause them are outlined.

It is determined that challenges and risks that are emerging in the world economy today have a significant impact on the economic environment of Ukraine in the short and long term, require the search for new strategies and tools for economic security, which will also determine new directions of the economic security policy of the state as a whole, industries and individual entities.

It is proved that the formation of an effective system of financial and economic security of agricultural enterprises, proper information and analytical support for its management is important both for the enterprise itself and in the context of the effective functioning of the economic security system of the state.
