**FORMATION OF STATE FINANCIAL POLICY AS DETERMINANT OF SUSTAINABLE DEVELOPMENT UNDER THE IMPACT OF GLOBALIZATION PROCESSES**

The intensification of globalization processes in the world, accompanied by the growth of international cooperation in all spheres of public life, in particular, production, trade and financial intermediation, has led to the elimination of transnational borders of movement of goods and capital. The sustainable development strategy of Ukraine till 2030 establishes a comprehensive system of strategic and operational goals for the transition to integrated economic, social and environmental development of Ukraine, which necessitates the modernization of the state financial policy in accordance with new strategic goals, objectives and guidelines for social progress. Under these circumstances, the study of the peculiarities of the impact of globalization processes on the processes of formation of the state financial policy as a determinant of sustainable development of Ukraine is a topical issue in both scientific and practical aspects.

The purpose of the article is to highlight the latest trends of globalization, to define the concept of "sustainable development" and substantiate the theoretical and methodological foundations of state financial policy as a determinant of sustainable development in the context of globalization.

The article examines the essence of globalization and the features of the impact of globalization processes on the development of society. Given that the evolution of the concept of "globalization" has been occurring as a result of changes in views on the level of coverage of the spheres of public life by globalization processes (economy, culture, politics, ecology, management, etc.), the current trends in globalization processes have been identified. Scientific approaches to defining the concept of "sustainable development" have been systematized, and the relationship of its main determinants (economic, social, ecologic and political) has been investigated. Special attention has been paid to the state financial policy as one of the determinants of ensuring sustainable development in the context of globalization. On the basis of generalization of scientific approaches, the author's definition of the category of "state financial policy" has been proposed, and the prospects for harmonized formation of state financial policy as a determinant of sustainable development under the conditions of globalization have been substantiated.
