FINANCIAL DECENTRALIZATION AND LOCAL ECONOMIC DEVELOPMENT

The article examines the basic principles of local budget formation in the context of decentralization of power. The structure of local government budget revenues and the dynamics of local budget revenues over the years of implementation of the reform of the territorial organization of power in general in Ukraine and in Chernihiv region in particular are analyzed. The importance of intensifying local economic development as a factor in strengthening the capacity of territorial communities and the success of their development is pointed out.

The article emphasizes that the reform of the territorial organization of power, or as it is often called - decentralization, is considered perhaps the most successful reform in Ukraine. In 2020, the formation of a new territorial basis for the activities of local governments was completed. As a result of the reform, all communities received the same powers and resources, and with them the responsibility for the development of their own territories. This has provided a basis for strengthening the capacity of communities to provide a range of public services and improve the quality of life of their residents. At the same time, there is a so-called sectoral decentralization - in the fields of medicine, education, provision of social and administrative services, in other areas. But the decentralization process is based on financial decentralization, which has made local budgets less dependent on the state budget, created opportunities for territorial development planning and implementation of infrastructure and social development projects.

It is proved that the strategic task of decentralization reform, which is currently in its final stages, is to form effective and capable local self-government, create comfortable conditions for citizens regardless of their place of residence, provide high quality public services and bring them closer to people. Achieving these goals is possible only with the appropriate level of local economic development, financial security of the territories and sufficient sources to fill local budgets. The success of the functioning of territorial communities and their capacity depends primarily on the financial security for the implementation of the powers defined by current legislation of Ukraine, and the availability of resources for development.

According to the survey, Chernihiv region has been at the forefront of the process over the years of decentralization reform and has been consistently in the top five regions.

It is concluded that increasing the financial capacity of territorial communities is inextricably linked with the intensification of local economic development, and decentralization in the budget sphere is an important tool for ensuring financial stability of regional socio-economic systems and economic development of regional economic complexes. Financial decentralization has made local budgets less dependent on the state budget and created the conditions for planning further community development and implementing these plans. At the same time, local governments should effectively use all available tools to intensify economic development in order to strengthen their own sources of funding, capacity for self-sufficiency and self-development based on the use of existing economic potential.
